CryptoWidgetToolkit turns web content - articles, stories, posts, videos, and even long emails - into a great reading experience, anywhere, anytime.

Please read these Terms of Service (collectively with CryptoWidgetToolkit's Privacy Policy and DMCA Copyright Policy, the "Terms of Service) fully and carefully before using www.CryptoWidgetToolkit.com (the "Site") and the services, features, content or applications, including the CryptoWidgetToolkit application (the "Application") offered by Instant Paper, Inc. ("CryptoWidgetToolkit", "we", "us" or "our") (together with the Site, the "Services"). These Terms of Service set forth the legally binding terms and conditions for your use of the Site and the Services.

1. Acceptance of Terms of Service.

- a. By registering for and/or using the Services in any manner, including but not limited to visiting or browsing the Site, you agree to these Terms of Service and all other operating rules, policies and procedures that may be published from time to time on the Site by us, each of which is incorporated by reference and each of which may be updated from time to time without notice to you.

2. Eligibility
